



XII Military Orientation Camp

"GONZALO FERNÁNDEZ DE CÓRDOBA"

-The Great Captain- 2026

This camp is organized and planned to provide educational and formative structures based on respect and order, among other traditional values in the military and in our traditional Spanish culture.

It is adapted and designed for young people of both sexes, from 11 to 21 years old, who have certain interests related to the Armed Forces and the State Security Forces, or who are simply attracted to the activities of a very different camp where classes and physical and technical activities are given that have nothing to do with other camps, and that are very difficult to acquire outside of it.

It is not exclusively for the children of military personnel; everyone can come, although it is true that approximately half of the attendees are children or grandchildren of military personnel and members of the State Security Forces.

Of course, the forms and manners are very similar, if not identical, to those in real professional life, but adapted and nuanced, and without ever losing sight that this is a youth summer camp, where the attendees are children and adolescents, and that one of the fundamental premises is that they must have a good time, learn new things, live with their peers, foster camaraderie and companionship, and that the multiple activities carried out must be done safely.

This is not a camp where we are going to kill time, but rather we are going to make the most of it, both in physical and theoretical activities. All of them are aimed at personal autonomy, self-sufficiency, personal security, and geared towards teamwork within a unit, in which they are framed and which they end up identifying as their own.



Each person will be given the physical intensity in the activities that they need and demand, always thinking that both the attendee who asks for and needs more intensity in physical exercise, as well as the one who has less ability, should be satisfied, and that both will complete their camp with total satisfaction, as it is still a youth camp.

They will have our officers as monitors, some of whom are active military personnel, others already retired or in the reserve; from different corps of the Armed Forces and Civil Guard, who will guide them on the possible paths for entering the Armed Forces as professional soldiers or in the various academies for officers and non-commissioned officers, if they wish, and even in vocational training paths or university careers in civilian life.

A period of order, where the young person is given educational structures, the need to follow an established schedule, with duties and services, very well structured and organized, where there is no room for laziness or personal neglect, and which can be very useful not only in a subsequent military life, if there is one, but in any area of civilian life, and can be a very valid principle for structuring their personality.

It is not a punishment or disciplinary camp, nor is it for troublemakers; we expel the troublemakers.

To our camp come excited boys and girls, always voluntarily, it is essential that they come by their own choice and completely voluntarily, full of desire to have fun, to learn, and to share experiences.

The camp has a team with exceptional qualities, all of them have extensive experience in military-oriented youth camps.

DIRECTOR, for 12 years a professional Civil Guard (from 18 to 30), assigned to various operational units of the Corps throughout the country, now retired and a Law professional, will be the one who supervises and remains at the camp for its entire duration, as the ultimate and primary responsible person, and who will supervise the instructors and ensure the proper functioning of the activities. He is trained with the corresponding qualifications of Leisure and Free Time Monitor and Director from the Pere Tarrés Foundation. He will teach classes on civic-legal training and the use of handguns. Languages: Spanish and English.

INSTRUCTORS, section monitors, active military personnel, who come voluntarily during their vacation period, or retired military personnel, with extensive experience in the military, will manage the day-to-day and accompany the children at all times, and will help in field and close-order drill activities. They will do sports with them, give them theoretical and practical classes, and will be with them during leisure time, and will be an important reference at the camp. There are female instructors, certified as leisure activity monitors.

A specialized and specifically qualified monitor for climbing activities.



A certified aquatic lifeguard in charge of the camp pool whenever it is open and/or in use.

We apply an emergency and security plan to be prepared for situations that may eventually occur.

Of course, all attendees will have full coverage by the camp's accident medical assistance and civil liability insurance with Mapfre.

We have a very complete first-aid kit at the camp, field kits that are taken on all personnel outings off the property, and there is a complete and new hospital 10 minutes away by car, in Collado Villalba.

The boys and girls will not do exercises that are inappropriate for their physical condition; we will give each one the intensity and exercises they can handle and demand, none that create excessive risks, nor that are especially strenuous; we are not in an operational unit of the army; and we firmly believe in awakening them to reality and promoting teamwork and camaraderie.

They will perform duties typical of a military training barracks-academy, with the necessary nuances, but they will do them. And they will sew, wash their clothes, sweep, watch over their companions' sleep, and learn to belong, and to be accountable to someone other than themselves.

This is the list of some of the activities. Convinced that 7 or 15 days is not a long time, we bet on doing them well and with benefit. It is useless to fill pages with activities that there is no material time to do, or if they are done, it is in a rush.

Not all are listed and we can vary them depending on the schedule, so it is not a contractual obligation.

- Classes on civic and military behavior.
- Special care in education at meals, hygiene, nails, hair, posture, hands in pockets, forms, manners, correctness in dealing with peers and superiors.
- Monitors, instructors, and management will eat and live with them at all times.
- Practical classes on first aid, rescue in armed conflict situations.
- Basic self-defense no complicated martial arts "street" defense (adaptation to urban or rural environments), and when and how to use it.
- Prohibited and permitted weapons, their possession and use.
- Daily gymnastics according to abilities. Obstacle course.
- Survival and orientation exercises, and hardening military marches, and military and police patrols on the property itself, airsoft combat.
- They will sleep at least one night in the field. We have more than 40 hectares, but we



can use the rest of the natural park.

- Climbing, zip-lining, rappelling, etc., practiced on the property with a certified climbing monitor.
- Practical instruction in the military and police use of the pistol, the assault rifle; we will teach notions of a precision shooter, especially safety rules and methods with weapons (all used will be airsoft and with the proper protections).
- Swimming pool at the camp itself. Always supervised by a certified aquatic lifeguard during both day and night activities.
- We will teach those who do not know how to swim minimally to stay afloat and survive.
- It is not a recreational pool; it is a pool for aquatic exercises.
- Performance of prevention and personnel assistance guard duties by the camp attendees themselves, dormitory watches, cleaning of facilities; the idea is that they must work.
- Teaching of military close-order drill, formations, salutes, introductions, behavior, parades, etc.
- Tribute to the flag, its meaning, and constitutional framework. Having members from units of other countries, special emphasis on the treatment and respect for the signs and emblems of other nations.
- Camp and barracks games. Races and competitions by sections.
- We will have visits from Chiefs and officers and veterans who will share with us lived situations and peculiar circumstances and we will have the opportunity to share time with them.
- We always hold a camp-end ceremony and tribute to the Flag in a meeting with the parents on the last day before departure.

Location

The camp takes place on a private estate, exclusively; there is no one outside the camp. It is fully equipped and enabled for camps.

Rooms with bunk beds, and with their proper pillows and mattresses, boys and girls separated, sufficient and differentiated toilets and showers, indoor and outdoor dining areas duly shaded, outdoor toilets, the property's own swimming pool, indoor classrooms for



theoretical teachings, a chapel where mass will be held on Sundays for those who wish to attend.

A large green esplanade for military-type events and military instruction, a soccer field, and 42 hectares of mountain on a completely enclosed property for military-type practices and excursions.

Municipality of Navacerrada, community of Madrid, on the M-607 highway, kilometer 56.3, exit on the right-hand side dirt road. There will be an indicative sign at the entrance of the road. GPS point 40° 43′ 50″ N 4° 0′ 8″ W. (Make sure you set your navigator to W for west.)

Dates and Prices

- July 18 to 24, 2025, both inclusive (7 days)
- July 25 to 31, 2025, both inclusive (7 days)

It is possible to do one, two, three, or four weeks. To have the same learning speeds, differentiated groups will be made by length of stay. The dates are what they are, regardless of the day of the week they fall on, because the property is rented to us from day to day of the month each year and the start and end day is very clear; please do not come the day before or the day after because that is not what is contracted, and we will not be able to admit you except in extreme cases that you must discuss and consult with the management.

• One week: €750

• Two weeks: €1,400

Returning campers and multiple siblings get a €50 discount on the final price. For more than two attendees, please consult prices.

Enrollment Process

A spot is reserved with the payment of €200 as a deposit and after filling out the personal data questionnaire on the web at www.gran-capitan.es or with the completed form delivered and confirmed, which is provided if you request it at mellado@mellado.es.

You can pay the deposit, the full amount, as you wish and are able, but the deposit must be



paid at the time of registration. Without this deposit payment, there is no reserved spot, no matter how much you have filled out the personal data questionnaire, and the camp only gives the spot to whoever has paid at least the deposit or a larger amount.

We refund the reservation deposit in cases of justified accident or illness of the attendee that prevents them from coming before the start of the camp, or another reason that will be evaluated at the discretion of the organization but always with a justified cause.

Filling out the questionnaire and making the deposit payment means full acceptance of all conditions.

- 1. Read this informational PDF and the authorization and consent form carefully and completely. We recommend printing them. They are at the end of this document.
- 2. You must fill out and send the personal data questionnaire, through the digital questionnaire, which is on the link of the camp's website www.gran-capitan.es. If you wish to register several attendees, or it is not possible for you to fill out the digital questionnaire, request the Excel template at mellado@mellado.es as the web's digital questionnaire is configured to register only one attendee.
- 3. A deposit of €200 must be made as a reservation (or a larger amount, or the full price, as you prefer) to the following account:

 - Please indicate the attendee's name in the transfer concept to locate it quickly.
 - It is not necessary to send us the proof of payment by WhatsApp or email, as we control it with the bank's platform, but we will ask you to bring paper copies of the payments made on the day of arrival to speed up the process in case we have not found something.

Once the registration request is received and the €200 deposit is paid, you will have a reserved spot until the payment of the rest of the amount, which must be made before June 15, 2026. For payments made after this date, we guarantee nothing, as in past years some did not follow the rules and some kids were unfairly left out, and we will not allow it. (For other payment methods, contact the organization).

The travel expenses of the participants from their place of origin to the camp and back are not included in the activity price.

Those who register after June 15 must pay the full amount of the camp at the time of registration. As of June 15, reservations are no longer valid, only full and firm payment.

What's Included in the Price

- · Accommodation and full board meals.
- Comprehensive civil liability, health care for accidents and hospitalization, etc. insurance.
- Uniform, which becomes the property of the attendee (they will take it home), and will consist of:

• Barracks wear:

- 1 pair of multicam camouflage pants.
- 1 tactical inner belt.
- 3 short-sleeved camp T-shirts.
- 1 beret with camp emblem.

• Field wear:

- 1 pair of multicam camouflage pants.
- 1 multicam camouflage combat shirt.
- 1 multicam camouflage boonie hat.
- 1 tan-colored canvas belt.
- As indicated, this uniform becomes the PROPERTY of the attendee (it does NOT have to be returned and may be useful for future activities). All clothing is BRAND NEW. The list may be modified according to suppliers and according to quantity and shipping needs.

What to Bring

Documentation

• Health declaration and parental authorization-service provision contract signed by one of the parents or guardians, and a photocopy of the attendee's health card. This is delivered in paper, signed by at least one of the parents or guardians if the attendee is a minor, on the day of arrival. It is not necessary to send anything in advance as we need it in paper for the personal file.

Mobile Phone



• Charger and a charged battery. To be able to call home during the established periods. It is strongly requested that you let them bring a mobile phone, and if they do not have one, buy them a cheap prepaid one, as we can lend a phone in case of need to a few kids, but not to 200.

Clothing and Footwear

- Two pairs of shorts (preferably dark-colored and better if black). Sports shorts, not tights or leggings.
- Tights and leggings are not allowed. They can only be worn under the corresponding shorts.
- A pair of T-shirts and sports shoes, of any color, for sports, all of free choice.
- Several sets of underwear and socks, at least 5 changes (at each one's discretion) as they will wash clothes at the camp.
- Two summer pajamas.
- A sweatshirt or sweater. The camp is at a high altitude and the climate is high mountain, and an extra layer of warmth under the combat shirt may be necessary. A sweater or sweatshirt is enough, just in case.
- Military-type or mountain boots high-top. The important thing is that the ankle is supported, meaning the boot should rise at least 4 fingers above the ankle; this prevents 50% of injuries.
- VERY IMPORTANT to wear them before the camp so they don't cause wounds. Wearing them a lot for a few days before the camp helps to mold them to the foot and prevent chafing or blisters.
- Do not bring old or borrowed boots that are years old, which, although they may look new, are so only in appearance, as they are all degraded and break on the first day.
- Swimsuit, towel, and swimming goggles, if desired. Shower flip-flops. For girls, a one-piece swimsuit; bikinis are not allowed.
- Do not bring more clothes than what is listed, because it will only hinder you at the camp.

Laundry Supplies

• A bar of laundry soap (like "Lagarto" type) and a brush for washing clothes. Needle and white or black thread; they will sew.

Personal Hygiene Items

- Toiletry bag with shower gel, at least one liter.
- Soap



- Deodorant
- · Hand towel and bath towel
- Toothbrush and toothpaste
- Shaving supplies for those who need them
- Small nail clippers.

Field Equipment

- Small backpack (approx. 30 liters capacity) like those carried to school. (We have military camouflage ones at the camp for those who wish).
- Insulating sleeping mat.
- A thick winter sleeping bag. It gets cold there when the sun is not out. Do not bring "summer" bags as we are in the high mountains and there is no summer there.
- Waterproof jacket or poncho.
- Flashlight and spare batteries, a headlamp is better than a handheld one.
- Canteen that can be attached to the belt, minimum one-liter capacity.
- Face camouflage paints (can be found online, on Amazon or others, in airsoft stores and armories, and in large stationery shops).

Medications

- Medications, if needed, should be handed over upon arrival and we will administer them.
- If contact lenses are used, bring some spare disposables.

Note-Taking Material

- Half-folio size notebook.
- · Pen.

Airsoft Equipment

- Replica (for those who have one), protective goggles (Essential), charged batteries, charger, and BBs at each one's discretion. This is the minimum equipment for practicing the activity.
- Anyone who does not have an airsoft replica can rent one at the camp itself; payment is made upon arrival at the camp. The price is €40 per week of stay. The price includes the replica, BBs, and goggles. If you rent, you do not have to bring anything for airsoft or worry about it.
- Due to the current legislation regarding Airsoft replicas (B.O.E. of January 5, 2013 –



Order INT/2860/2012 of December 27), we want to emphasize that the transport, use, and possession of said replicas is under the total responsibility of the attendee.

• The camp organization will collect and safeguard the replicas within the camp grounds. They will be given to the attendees only for carrying out the corresponding activity, and then collected again until the end of the camp.

Any other equipment you deem essential. We should point out that some equipment you bring from home will be taken away by us for being unnecessary or not convenient, and it will be returned at the end of the camp.

Camp Rules and Regulations

We must emphasize that attendance at this camp SHOULD NOT BE a corrective measure, sanction, punishment, or similar for the attendee. Attendance is completely, completely voluntary, enthusiastic, and with a desire to learn and have a good time. THIS IS NOT A CAMP TO STRAIGHTEN ANYONE OUT. THIS IS NOT A CAMP FOR TROUBLEMAKERS.

This activity is solely designed for young people who wish to attend VOLUNTARILY, and who have interests, a vocation, and/or an interest in the Armed Forces and the State Security Forces, regardless of whether their intention is to join them or not. If such a situation is detected, the attendee would be removed from activities and/or expelled, after notifying their parents or guardians.

- The organization will include the participant in the contracted program, with the commitment to perform its obligations according to the strictest professionalism, and will take the necessary precautions for the normal development of the activities, but will not be responsible for damages caused by third parties external to it.
- Participants accept the camp rules completely and without reservation, its schedules and plan of activities. Anything else means expulsion without any refund for any reason.
- It is not recommended for excessively fainthearted, excessively weak, lazy kids, and those not used to doing some physical activity on a daily basis. It is not a camp to "wise up" anyone; it is a youth camp to have fun and learn and grow personally. It does not replace military service in any case. We cannot do in 7 or 15 days what you have not achieved in years.
- The camp, due to its continuous schedules and activities, involves a certain degree of toughness and personal will, not suitable for kids who do not do any type of sport and are excessively passive, sedentary, and of low spirit.
- Once inside the facilities, the camp period is considered to have started, and the rules specified above are in effect.



- The camp organization is not responsible for money, valuables, or the loss of personal items and/or clothing that may occur during the camp. They only need to bring a little money in case they lose a piece of clothing or want to buy something at a store on a military base we visit (maximum €30). The camp store with materials is open throughout the camp and on the day of arrival and departure, so if they want to buy something and do not have money, they can purchase it before they leave.
- No one can leave the camp for any reason without the knowledge of and accompaniment by the monitors and camp leaders.
- All attendees must respect their peers, instructors, and monitors at all times. They also have the obligation to shower and wash at the established times.
- The use of music players, video game consoles, or any other electronic device of this type is not allowed. Monitors and instructors are authorized to remove and keep them until the end of the camp if their use is detrimental to the proper development of the camp and the integration of the participants.
- Permanent possession of mobile phones, cameras, or similar devices by the attendee is not allowed. These will be collected and kept at all times by the camp organization, and will be handed out for periodic use as previously established for calling family, and then collected again.
- Participants will be able to call home (barring changes due to unforeseen events) on the days that the organization establishes, which will be announced on our Facebook page. We usually allow a period of 3 or 4 days to pass before the first call to get parents and children accustomed. The established call time will be from 10:00 PM onwards. For this, the attendee must obviously have a mobile phone.
- We must remember that one of the camp's objectives is to foster the independence and autonomy of the participants, so CALLS OR VISITS WILL NOT BE ALLOWED except, obviously, for very important reasons, for which you must contact the organization's phones in advance.
- Attendees cannot change their assigned accommodation unless authorized by the organization.
- All materials and facilities belonging to the camp must be used and respected properly by the attendees. If not, the organization will take appropriate measures. The costs of repair and/or replacement in case of damage due to improper use of furniture, movable property, damage caused to third parties, etc., will be charged to the attendee's parents/guardians, who must pay them directly to the activity's organization.
- The camp is organized with the participants in mind, in such a way that we guarantee their well-being. In the event that a participant suffers an illness, accident, or simply does not feel well, we will immediately contact the family to inform them and take



the necessary measures.

- It is strictly forbidden to consume alcohol or other prohibited substances, destroy objects, appropriate others' property, etc. Likewise, it will be totally forbidden for them to smoke; if your child smokes, it is better not to bring them because we will surely expel them.
- It is strictly forbidden to carry pocket knives, including multi-tools, machetes, hunting knives, darts, laser pointers, and any object that could cause accidents or injuries. Monitors are authorized to remove and keep them until the end of the camp.
- If necessary and for obvious safety reasons of the attendees, the organization may search backpacks, bags, luggage and/or personal effects, as well as when there is suspicion of the commission of an illegal act against the organization's property or the participants themselves.
- If any participant needs to take medication, they must notify the camp leaders upon arrival, as it is not convenient for them to have it in their possession. They will be given it according to the prescription each day.
- Seeking the best interest and safety of the participants, the organization reserves the right of admission for those with medical limitations for physical or psychological reasons, as well as psychological and medical reasons, which have not been reported but are detected once the participant has been received at the camp and which could put their health at risk in the programmed activities, or the health and safety of others at the discretion of the organization. The admission will be at the judgment of the technical team, communicating the reason for the suspension to the parents or guardians and if they are removed from the activities.
- The consumption of food or drinks other than those provided by the camp's kitchen service is not allowed, except for consumptions made during trips, or those justified by a special diet.
- Attendees' own airsoft replicas travel, from origin to the camp and vice versa, under
 the total responsibility of the attendee, who at no time should use or display them
 outside the areas and activities prepared for that purpose (B.O.E. of January 5, 2013 –
 Order INT/2860/2012 of December 27). During the camp, the replicas will be kept by
 the organization at all times. They will be handed out to carry out the corresponding
 activity and then collected again.
- The organization is exempt from liability in case of acquisition by the attendee of any material during visits to shops scheduled by the organization. The organization may proceed to take custody of said acquired material if it is likely to create a risk to the physical integrity of the purchaser or other persons.
- In case of non-compliance with any of these criteria and rules, it will be studied by the organization, taking the appropriate measures and reserving the right of expulsion from the camp, which in no case will give the right to compensation of any kind. Any



serious offense can mean the expulsion of the participant, after a phone call with the parents or guardians. All resulting expenses will be borne by the parents/guardians, who may not demand any type of refund.

- In case of voluntary withdrawal from the camp, or due to injury or expulsion, no amount will be refunded for any reason, as we pay the cost of the stays completely in advance.
- Likewise, any situation that occurs at the camp by any attendee that could negatively influence its proper development will be assessed by the organization, which will act accordingly. Of particular importance is not following the camp's activities, hindering them, or being a bad influence on the rest of the attendees or incurring in any of the prohibitions, or representing a special hindrance or danger to the safety of third parties, their peers or monitors. In such a case, expulsion will proceed and no amount will be refunded for any reason.
- Registration and attendance at the camp implies the acceptance of all the rules detailed above, both by the attendees and by the parents or guardians of the minor in all their points and sections.
- Attendees must maintain their medication, if they need it, just as when they go to school, no matter how much the doctor gave a "break" during the vacation period, as the degree of attention and disposition must be the same as at school. This is especially indicated for kids affected by hyperactivity, who in many cases are given a "break" by their doctors in the summer believing they will be calm at home, but our camp has a level of demand close to that of school, so that pause is not convenient while they are at the camp.
- The drop-off and pick-up of families and children at the camp will always be at times permitted and stated by the camp management, and always so as not to hinder the camp activities and always during the day. The camp staff are under no obligation to attend to them at night or at times that hinder the activities or the rest of the attendees or monitors and members of the collective. The hours for attending to parents are set by the camp and will always be from 9 a.m. to 8 p.m.
- Our camp does not promote, nor does it intend to promote any type of ideology, none, it is radically neutral. It is a camp for boys and girls enthusiastic about the police and military world, eager to learn and make the most of their time, and to promote and enhance values of friendship, solidarity, commitment, dedication, work, effort, courage, among others, nothing more, and nothing less. Therefore, we do not tolerate any type of manifestation by anyone in any political or ideological sense.
- On the starting days of the camp, we admit kids from 9:00 a.m. to 1:30 p.m. as a general rule, because we want everyone to be registered, admitted, and equipped by lunchtime to start doing things. Whenever possible, if someone has no other way and arrives later, they will also be admitted.



- Upon arrival at the camp, you must report your arrival, register, and submit the following documentation:
 - Parental authorization and service provision contract with acceptance of conditions signed by one of the parents or guardians for minors or acceptance of conditions (for adults). It is found on the last pages of this file.
 - Medical questionnaire (last page of this file).
 - Paper proofs of payments made.
- On the last day of each session, that is, on July 24, July 31, August 7, and August 15, we hold the ceremony in tribute to the Flag and the end-of-camp ceremony. We open the gates at 10:00 a.m. for the entry of vehicles and families, they close at 11:45 a.m., and at 12:00 p.m. the ceremony begins, which lasts approximately one hour. At the end of the ceremony, your children will meet you in the parking lot and you can leave. The house does not provide food to anyone on the last day, so each one will have to make their own arrangements. During the ceremony and in the times before and after it, we will have chairs for disabled and elderly people, as well as services for the public.

Both the participant and the parents or guardians in case of minority, are informed and in complete agreement with the following points:

- 1. They show their conformity with the activities programmed for the development of the event and accept any variation in the programmed activities that the organizers are forced to introduce due to any circumstance.
- 2. That the attendee must accept the safety and behavior rules indicated by the activity leaders, authorizing them to impose their professional judgment.
- 3. They authorize the camp management for the treatment of minor wounds and ailments and the transfer in a private vehicle to the nearest hospital emergency service, and if necessary in an ambulance, authorizing them in their absence to ensure the health and integrity of the attendee at all times, according to the guidelines of official and regulated medicine. I extend this authorization in case of maximum urgency to the activity leaders, with knowledge and prior medical prescription, to make the appropriate medical-surgical decisions, in the event that consulting me is impossible.
- 4. In case of withdrawal or abandonment by the attendee, or due to injury, whatever the moment and the cause, once the camp has started, no amount will be refunded as the camp expenses are generated from entry into it, and once started there is no possibility of filling that spot.
- 5. The attendee must assume and abide by the discipline that governs the camp, forms, manners, and education, and that will be applied in the activity. Anything else may result in a sanction and, depending on the severity, immediate expulsion.
- 6. To possess an adequate state of health to carry out the activities of this camp, and



- sufficient minimum psychophysical capacities to attend a summer camp in coexistence and with sufficient personal autonomy.
- 7. Not to wear any kind of piercings, earrings, bracelets, necklaces, etc., during the development of the activity, in addition to not taking any type of drugs, alcoholic beverages, nor smoking smoking is completely prohibited by law. Lighters, knives, and any electronic and dangerous object detected will be confiscated and returned upon departure.
- 8. Not to have omitted, misrepresented, hidden, or lied about the physical and mental health status of the attendee. Any omission, absence of medication if necessary, or falsehood will result in expulsion from the camp, without the right to any compensation. The attendee, if needing medication during the academic school year for ADHD, or any other illness or pathology, must continue taking the medication during the camp, as the stress they may be subjected to and the need for attention is the same.
- 9. **VERY IMPORTANT.** The camp attendee will remain in it as long as they carry out the activities normally and regularly, and according to the criteria of the organization. The moment they must cease the activity, at the discretion of the organization, for being a danger to themself, to the monitors, or to other kids, due to an illness that does not allow their dignified stay, or requires hospital admission, or the exclusive surveillance of the monitors, or due to incorrigible indiscipline, the family or guardians listed in the registration will be notified, and in the following 12 hours they will come to pick them up without any excuse, and without delay, regardless of their place of residence or stay. Otherwise, the Civil Guard and the Juvenile Prosecutor's Office will be notified to take charge of the minor and for them to be attended by the Social Services of the Community of Madrid, (reserving the right to take legal action against the parents for damages caused by the breach of contractual conditions). It is therefore very important that if you are required by the camp management to pick up your child, you do so without undue delay and cooperate with the smooth running of the activities. Having contracted the camp does not mean that we must keep your child no matter what and that they are left parked there, and for the total duration of it in any way, but it means the right to participate in the camp as long as they are in sufficient condition and do not represent a burden for the rest of the camp, management, and collective. The contract ends without the right to compensation of any amount at the moment your child, at the discretion of the organization, should not continue with the camp for its proper functioning. The camp management wishes that the largest possible number of kids finish it, and hopefully all of them, because each withdrawal or expulsion is a failure for us, for the kids, and for the family. There is nothing more satisfying for us than seeing them grow.

I exempt the organization of the event Camp Gonzalo Fernández de Córdoba - El Gran Capitán, and the Instructors of the activity from all responsibility in case of any type of incident caused by disobedience or non-compliance with the established rules, as well as in



the case of the acquisition by the minor attendee of any material during scheduled visits to shops, the organization being able to take custody of said acquired material if it is likely to create a risk to the physical integrity of the acquirer or other persons.

The pick-up and arrival of families and children at the camp will always be at times permitted and stated by the camp management, and always so as not to hinder its activities and always during the day. The camp staff are under no obligation to attend to them at night or at times that hinder the activities or the rest of the attendees or monitors and members of the collective. The hours of attention to parents are set by the camp, and you expressly accept them, and will always be from 9 a.m. to 8 p.m.

Likewise, I authorize the Camp Gonzalo Fernández de Córdoba - El Gran Capitán to make the appropriate recordings (video / photography) in which the aforementioned minor may appear during their attendance at the activities carried out by said camp, as well as their dissemination for commercial purposes exclusively of the camp, and through any support or social network used. Said images will never be transferred to a third party for any reason.
